



Pea Patch Field Use Policy

The following rules are to outline the use and rules of the Pea Patch Playfields.

1) Field Use Fee

An hourly fee will be billed for any usage of a field.

- a) 2016/2017 hourly rate for any size Pea Patch field is \$25 per hour.
- b) The hourly rate can be divided between a maximum of 3 teams.
- c) If a single team is using the field they are responsible for the full field fee.

2) Per field Player Limit

Each field can have up to a maximum of 40 players practicing/playing on it at any time.

3) Field Lining

Field lining is included with the standard field fee From September 1st to June 1st. Between December 1st and March 15th and June 2nd to August 31st field lining has the following fee structure:

- a) Initial field lining setup fee is \$45 per field.
- b) Field lining maintenance of \$15 per field per week scheduled, regardless of many days practice or games are scheduled.
- c) Any requested field lining will be done once per week.
- d) Field lining setup includes the setup of a net with the goals.
- e) Field lining cannot be done by any Associate Member or partner using the fields.
- f) Outside paint on these fields is not permitted.
- g) Any field lining must be requested at the time of the field use request or 2 week prior to the event date.

4) Garbage

There are no garbage cans on site. Make sure your team cleans up after themselves and PACK all of your garbage out with you.

5) Storage Container Access

Access to the storage container is allowed only by KCYS personnel and authorized coaches. Access to the storage is not permitted for any Associate Members.

6) Responsible Parties

It is the sole responsibility of the **head coaches** of teams that use the Pea Patch fields to notify their teams and visiting teams and enforce the rules of the Park. Coaches must make sure all players and fans associated with their team are informed. Coaches that don't adhere to this policy for any reason will forfeit future scheduled dates in the park. The rules will be enforced strictly.

- a) No metal cleats allowed anywhere in the park.
- b) No smoking or use of smokeless tobacco anywhere in the park.
- c) No alcohol in any area of the Park.
- d) No jumping or climbing of or on any fences, roofs, goals, or netting.

- e) Abusive language by players, coaches or fans toward anyone will not be tolerated.
- f) Employees of King County Parks, Kent Covington Youth Soccer, or Kent United have authorization to enforce all rules of the park.
- g) No pets are allowed in the grass fields area, but are allowed in the parking lots.

7) Penalties

Failure to follow this policy could result in additional fees, loss of future scheduled time, or loss of membership.

This Park is in our hands. Please keep it that way by taking care of it. Any reports of misuse, unscheduled use, vandalism, or etc., could revoke the use of the park by a person, team, and/or organization along with any criminal charges that could be levied. All other existing rules for the King County Parks system and Pea Patch fields apply for all area of the Pea Patch fields. Please use the park responsibly and have fun!
